		<p>*National visa application form: Each applicant must complete and sign a visa application, filling in each of its sections. If the applicant is a minor, both of their parents or a duly accredited representative must sign the application.</p>
		<p>*Valid, unexpired passport. Original and a photocopy of the page or pages of the passport that contain biometric data. The passport must have a minimum validity period of 1 year and contain two blank pages. Passports issued more than 10 years ago will not be accepted.</p>
		<p>*Previous Passports.</p>
		<p>*Legalized and translated Shenanameh: (Spanish translation for the last 6 month). If anyone has been born in Spain, he/she should provide it.</p>
		<p>*Photograph: A recent, 3.5*4.5,(for the last 3 month) color photograph,, taken against a light background, facing forward, without dark or reflective glasses, or any garments concealing the oval of the face.</p>
		<p>*Proof of financial means (Only for Investor’s family members): Original and a copy of the documents proving that the applicant (or their legal representative or the family member supporting them) has sufficient financial means to cover the expenses of the student's stay and return, as well as the stay and return of the family members accompanying them. The minimum required amount is equivalent to 100% of Spain's Public Multiple Effects Income Indicator (IPREM) for each family member. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish.</p> <p>*Proof of financial means (Only for ENTREPRENEUR’s family members): Original and a copy of the documents proving that the applicant (or their legal representative or the family member supporting them) has sufficient financial means to cover the expenses of the student's stay and return, as well as the stay and return of the family members accompanying them. The minimum required amount is equivalent to 50% of Spain's Public Multiple Effects Income Indicator (IPREM) for each family member</p>
		<p>*Health insurance: Original and a copy of the certificate accrediting the public or private health insurance contracted with an insurance entity authorized to operate in Spain. The insurance policy must cover all the risks insured by Spain's public health system. If the applicant is participating in a volunteer program, in addition to the medical insurance, they must provide a copy of the civil liability insurance policy taken out by the organization.</p>

		<p>*Criminal record check certificate. (for the last 3 month): Applicants of legal age who apply for a visa for a stay of more than 180 days must submit the original and a copy of the criminal record check certificate(s) issued by their country or countries of residence for the past-2 years. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish. Additionally, a declaration will be submitted stating that there is no criminal record for the last five years.</p>
		<p>*Documents proving family relationship with the investor: birth or marriage certificates issued by the civil registry, certificate of registration as an unmarried couple or any other document proving that the relationship is an unregistered partnership. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish.</p> <p>In the case of adult children, documents proving their financial dependence and civil status. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish.</p> <p>In the case of relatives in the ascending line, documents proving they are in the investor's care. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish.</p> <p>Marriage certificate: (dully legalized and translated into Spanish by a sworn translator). For spouse, Birth certificates: (dully legalized and translated into Spanish by a sworn translator) for children.</p>
		<p>*Photocopy of the Residence Card/ National Visa of the family member (INVESTOR) / ENTREPRENEUR, in the event that family members submit their applications after.</p>
		<p>*Proof of residence in the consular district (only for non Iranian nationals).</p>
		<p>*Proof of the representative's identity and capacity. If the visa application is submitted through a representative, a copy of the identity document or passport of the representative and of the power of attorney or document accrediting representation must be submitted. The originals must be shown when submitting the application. Foreign documents must be legalized or apostilled and, where applicable, must be submitted together with an official translation into Spanish.</p>
